Only those non-profits that are organized in accordance with specific eligibility standards can receive funds. Services provided must assistance low and moderate income person within the City limits of Morganton.

All funds MUST be spent by 4-30-2019

HUD highly encourages projects that provide housing and/or housing assistance for low and moderate-income persons, including the homeless. Bonus points will be given to projects containing these objectives.

Organizations applying for CDBG funds must submit the following documentation:

 - ___ Job creation/retention
 - ___ Very low income (less than 50% of area median)
 - ___ Persons with developmental disabilities
 - ___ Persons with alcohol and other drug addiction
 - ___ Persons with physical disabilities
 - ___ Public Housing residents

A provision for assisting low and moderate-income persons must be a component of the organization's purpose/mission statement.**

___4 A 501 (c) designation letter from the IRS. Can be either 501 (c)3 or 501(c)4. Section 905 Subordinate Organizations must be identified by IRS as a public charity.

___5. A copy of the organization's By-Laws

___6. A notarized statement by the chief financial officer or from a Certified Public Accountant that certifies the organization's compliance with the Uniform Administrative Requirements outlined in sub-part 570.502 CFR.

___7. Capacity. Submit resumes or statements that describe the experience of accomplished key staff members and consultants who will be involved with projects assisted by CDBG funds. List the number of full-time, part-time and volunteers staff members.

**___8. Experience.
A. A statement, signed by the president of the organization, that documents at least one year of experience in serving the community, or
B. For new organizations, a signed statement that documents that its parent organization has at least one year experience in serving the community.**

Eligible CDBG Activities

Non-profits may apply for CDBG funds to conduct activities that will benefit low and moderate-income persons as follows:

1. Area benefit activities as described in 570.208(a)(1) CFR (copy attached)
2. Limited clientele activities as described in 570.208(a)(2) CFR (copy attached)
3. Housing activities as described in 570.208(a)(3) CFR (copy attached)
4. Job creation or retention activities as described in 570.208(a)(4) CFR (copy attached)

****Please note that non-profits that have NOT received funding for the past two consecutive years will be given priority for funding in FY 2018. Community Development Staff wants to make these funds available to all qualified non-profits and provide an equal chance to receive CDBG funds to all local non-profits.**
